CCF = 100 cubic feet or 748 gallons

Example Of New Monthly Billing:

LHMWD's average customer uses approximately 450 gallons of water each day throughout the year. This amounts to 19 CCF (billing units) over a 1-month billing period. One CCF = 100 cubic feet or 748 gallons. The average customer's bill would then be calculated as follows (excluding other applicable charges such as lift charges, sewer and trash collection charges, and/or other City services):

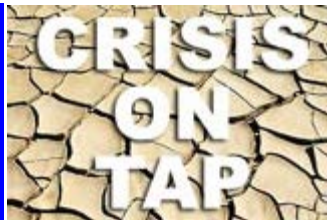


WATER-WISE PLANT SALE AT THE HEMET HOME DEPOT, 4/26/14
