## JOB SUMMARY

This is the advanced journey level performing Senior Environmental, Health and Safety Field Specialist job duties.

### DISTINGUISING CHARACTERISTICS

Positions at this level are recognized as technical specialist using initiative and resourcefulness in deviating from traditional methods or researching trends and patterns to develop new methods, criteria, or proposed new policies. Decisions regarding what needs to be done include interpreting data, planning of the work, or refining the methods and techniques to be used. The work involves established criteria; formulating projects; assessing program effectiveness; or analyzing variety of unusual conditions, problems, or questions. The work product or service may affect activities, or the operation of other organizations.

This classification is an alternative to the management track for advancement, and is consistent with the concept of a dual career path. This classification includes two categories: 1) A Technical Specialist within a defined area of specialty or 2) A Project Manager for projects of large or above average complexity. This individual ensures that the level of service and support provided meets the Metropolitan Water District Standards.

**Technical Specialist:** Acts as a lead and provides technical expertise for a major functional area or a specialized field for projects that are complex or multiple smaller projects. They are recognized as technical specialists in their field or discipline who would provide technical advice and policy recommendations to project teams and Program Managers.

**Project Manager:** Acts as a lead and is responsible for project management for projects of large or above average complexity, involving negotiation of agreements or discussions of technical issues with peer and senior-level contacts outside of the District and are of moderate to high visibility and sensitivity to Metropolitan in the area of its core business initiatives. They are responsible for identification of major project decisions and policy recommendations to be brought to management's attention.

## OVERSIGHT

**Supervision Received:** Receives direction from the Team, Unit, Section, Assistant Group, or Group Manager.

**Supervision Given:** Acts as a lead. Coordinates and reviews work assignments of employees performing the same general work as the lead on a day-to-day basis. Responsibilities may involve solving problems and providing instructions on work procedures.

## JOB DUTIES

- 1. Provides specialized expertise to develop and implement health and safety programs to meet regulatory requirements; and develops communication and program roll out standards in coordination with program support staff.
- 2. Directs field audits to ensure compliance with program requirements. Documents results and recommends corrective action where deficiencies are found. Works with program managers to ensure that environmental, health and safety programs and supporting systems and tools meet facility and operational needs. Conducts follow-up, as required.
- 3. Conducts evaluations of consistency of environmental, health and safety field support activities. Compiles reports and provides recommendations to management.
- 4. Participates in the development and delivery of training related to environmental, health and safety programs Ensures that required environmental, health and safety field records, files, reports and administrative paperwork is prepared, maintained and organized. Prepares reports, as requested or required. May contain confidential information.
- 5. Liaises with regulatory agencies and professional organizations; oversees outside contractors.
- 6. Leads Environmental Health and Safety field implementation process improvement projects.
- 7. Provides and coordinates Environmental Health and Safety support to shutdown projects.
- 8. Leads safety committee activities at one or more facilities.
- 9. Performs other related job duties as required.

#### MINIMUM QUALIFICATIONS

#### Education and Experience:

Bachelor's degree from an accredited college or university in a related field and six years of relevant experience; or three years as a MWD Environmental, Health and Safety Field Specialist III level (effective through June 2015).

**Required Knowledge of:** Technical aspects of environmental, health and safety regulations and programs as they apply to industrial facilities and water treatment and distribution operations.

**Required Skills and Abilities to:** Understand and follow oral and written instructions; apply knowledge of environmental health and safety requirements to field operations; communicate clearly and concisely, both orally and in writing; establish and maintain effective working relationships with those contacted in the course of work.

Will work in proximity to various industrial and construction settings monitoring operations to support environmental program development and implementation.

This classification performs work that requires maintaining confidentiality and is routinely privy to matters that either involves confidential information, sensitive personnel issues, or exposure to confidential and sensitive strategic corporate information.
