JOB SUMMARY

The Water Quality Laboratory Manager is responsible for managing and supervising all laboratory functions associated with either a chemistry or microbiology discipline. Areas of responsibility include compliance monitoring; analytical methods development; technical support to outside agencies and other Metropolitan sections, units, or teams; and interfaces with outside agencies (regulatory, member agencies, advocacy groups, etc.) as Metropolitan representative.

OVERSIGHT

Oversight Received: Receives general direction from the Water Quality Section Manager.

Oversight Given: Manages and supervises through subordinate managers and supervisors a staff of chemists, microbiologists, laboratory technologists, and administrative support.

JOB DUTIES

- Manages all activities related to laboratory testing, analyses, documentation, and reporting to achieve compliance with state and federal water quality regulations; and ensures that all applicable sampling, testing, and analyses programs are properly implemented. Maintains proficiency in all drinking water regulations (current and future) and works with water quality staff to ensure 100% compliance.
- Develops and maintains quality assurance programs to ensure compliance with applicable operating regulations and meets accreditation standards set by the state and federal governments; and investigates water quality problems or irregularities to identify causes, determines proper remedies, and takes appropriate corrective actions.
- 3. Directs research programs to evaluate existing methods and develops new methods to provide cost-efficient and accurate analytical tools, conduct occurrence studies of contaminants of current interests, and conducts emergency response activities. Provides technical and analytical support to research programs on water quality treatment.
- 4. Analyzes and prepares technical, scientific, economic, and/or financial information for assigned projects; and reviews and evaluates proposed agreements, technical documents, scientific manuscripts, and project plans for compliance with applicable standards, guidelines, and objectives.
- 5. Ensures that all hazardous materials and hazardous waste procedures are adhered to. Manages the laboratory safety officer and committee to administer the required safety procedures and ensures that safety procedures are in place and complied with.

- 6. Establishes goals, objectives, and priorities that support the overall strategies of the section and Metropolitan; and identifies and develops capital investments and maintenance projects needed to meet reliability and water quality objectives, regulatory requirements, and customer demands for high quality water; plans, develops, and /or approves schedules, priorities, and standards for achieving goals.
- 7. Oversees and participates in the development and administration of the annual budget; participates in the forecast of funds needed for staffing, equipment, materials, and supplies; monitors and approves expenditures; implements adjustments; authorizes purchase of and ensures the proper inventory and accounting techniques of all materials, chemicals, and equipment; and evaluates and approves bids for equipment and service contracts.
- 8. Selects and assigns staff ensuring compliance with all hiring and promotion policies and procedures; responds to employee grievances and concerns; coaches and mentors employees; prepares, reviews, and approves performance evaluations; identifies employee development and training requirements; and develops staff recognition programs.
- 9. Serves as project team member and/or team leader for major projects involving substantial capital improvements, special local, regional or state-wide task forces, joint ventures with member agencies, and other external entities to ensure successful completion of project plans. Works with consultants on projects to ensure compliance with specifications and successful outcome.
- 10. Represents Water Quality Section Manager in his/her absence as appointed by the Section or Group Manager.
- 11. Performs other related duties as required.
