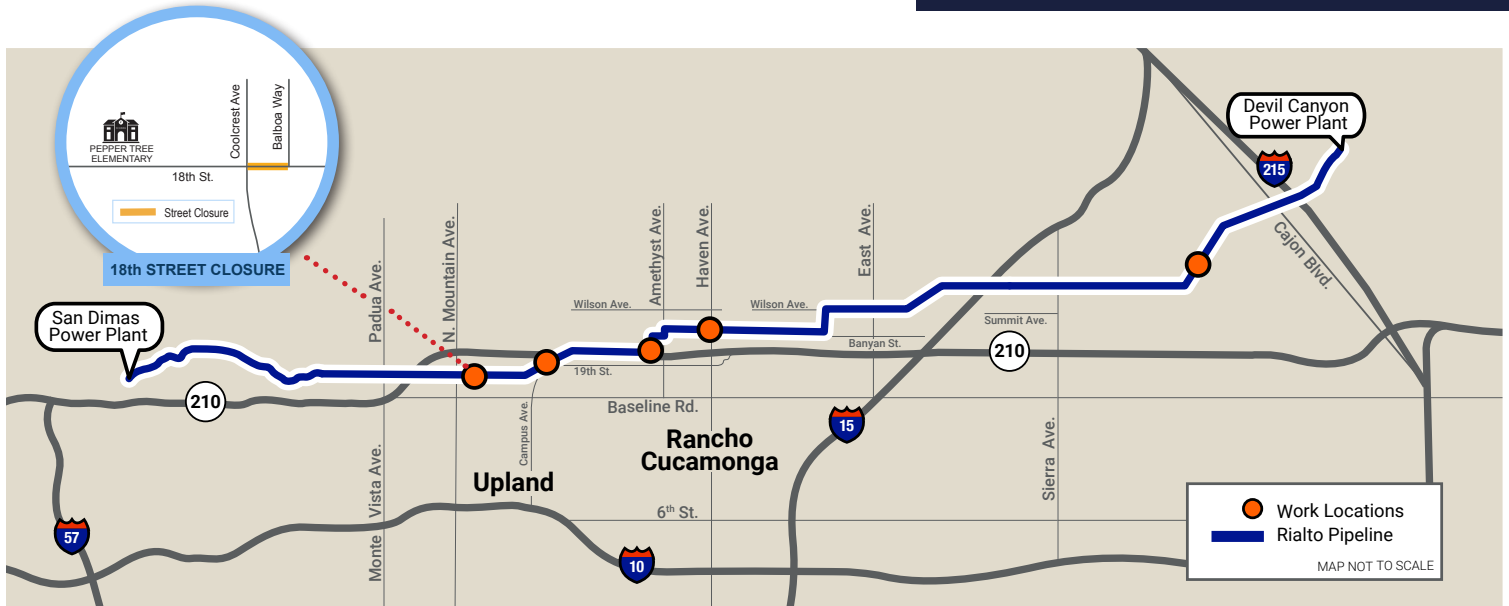

## Rialto Pipeline Rehabilitation Project

Built in 1972, the Rialto Pipeline spans approximately 30 miles, delivering untreated water from the State Water Project to Metropolitan's F.E. Weymouth Water Treatment Plant in La Verne. This project includes replacing a 35-foot-long segment of steel pipe and upgrading valves to enhance the pipeline's long-term reliability and support future water supply needs. Work will occur at various locations along the pipeline.

## What to Expect During Construction

- Noise from construction activity
- You may notice water on the street due to dewatering of the pipeline
- Temporary traffic delays, lane and parking restrictions
- 24-hour work may be necessary



## Frequently Asked Questions

### Why do you need to work 24 hours a day, 7 days a week?

24-hour work is necessary to complete the project in an efficient and timely manner. Our goal is to resume normal operating conditions so that we can ensure a reliable supply of water to our member agencies.

### Will this project affect my water service?

No. Water will still be delivered by your local water service provider without service interruptions.

### Am I going to hear construction noise all night long?

The majority, if not all, of the work done at night will occur underground within the pipeline, minimizing the noise. You may hear noise from generators needed to operate the ventilation system in the pipeline.

### How will this impact traffic?

Traffic control, lane restrictions, temporary no parking zones and detours will be in place during construction. Please take appropriate safety precautions and allow extra time to travel through the area.
